General Education Subcommittee Business

Multicultural Competency Task Force – Katrina Caldwell provided an update on the work of the multicultural competency task force. Following its first meeting in January, the task force examined multicultural competency models and processes in the literature and implemented at other institutions. Task force is also examining the impact multicultural competency may have on faculty and IHL requirements. The task force will propose models to the General Education Committee for consideration.

General Education Committee Values Subcommittee – Subcommittee members provided an update on the work of the subcommittee Following meetings in February, a small group edited the values statement to be considered at the subcommittee's next meeting. The subcommittee will prepare a statement for the General Education Committee to consider.

General Education Committee Business

EDHE opportunities for partnership – Representatives from the General Education Committee met with the Assistant Director of CSSFYE and discussed opportunities between the General Education Committee and EDHE 105. Such opportunities exist and should begin with open dialog between the committee and EDHE 105.

General Education Comprehensive Review

The committee discussed the process for determining if courses meet learning outcomes associated with general education competencies and/or align with IHL core requirements as well as other institutional requirements. The General Education Committee is the body to determine if a course meets such requirements.
