General Education Committee Business

Committee members reviewed the General Education diagram and the various components of IHL, SACSCOC, and UM competencies and core curriculum requirements and map of IHL core requirements by degree program.

Rich Forgette offered the following motion:

MOTION: To comply with SACSCOC Core Requirement 9.3 (see below) and IHL Board Section 512, the University of Mississippi General Education Committee establishes parameters and procedures for the core requirement across Schools and the College of Liberal Arts. The following IHL core curriculum requirements may only be fulfilled by undergraduate courses with departmental course designators from the following:

- Fine Arts Appreciation – Art History, Music (Mus 101, 102, 103, 104, 105), Theatre & Film (only Thea 201, 202, Danc 200)
- Natural Sciences – Astronomy, Biology, Chemistry (not Chem 101), Physics, Geology
- Mathematics – Mathematics (not Math 245 and 246)
- English Composition – Writing & Rhetoric (Writ 100, 101, 102; Liba 102)
- Social or Behavioral Sciences – Anthropology, Economics, Psychology, Political Science, Sociology
- Humanities – Classics, English, History, Philosophy, Religion, G St 201, 202, AAS 201, 202, S St 100-level

Undergraduate courses outside of these core academic disciplines must be cross-listed with a course designator from one or more core academic disciplines to be included in the core curriculum.

General Education Committee discussed the motion.
